To Secretary of Tournaments: In the capacity of team captain, I hereby enter the above Named team in the events indicated and agree to abide by the Ohio Moose Tournament rules and Regulations prescribed by the United States Bowling Congress.

- : Each fee \$ 20.00 per event per person. Five-person \$ 100.00; two person events \$ 40.00; \$ 20.00 For each entrant in each individual event.
- : Handicap 90% of difference of each bowler's average and 210. 76-pin- limit.
- : Individual U.S.B.C. Sanction Card must be shown or pay \$ 20.00 per player.
- : \* The Moose Lodge Secretary must sign this entry, plus the Lodge's Seal.
- : Bowling Fee ( 3 games ) \$ 9.50; tournament expense fee, \$ 7.00 prize fee, \$ 9.50; total \$ 20. 00 Per event.
- : A bowler may participate but once in each event.
- : Prize fee will be returned 100% per event.
- : One Prize for each six entries.

Entrants will use their highest U.S.B.C. sanctioned league averages based on a minimum of 21 games for the 2020 - 2021 season. If current 21 game average as of March 1, 2020 is 10 or more pins above player's entering average, current average must be used. If no average last year, use highest average U.S.B.C. sanctioned average, 21 games or more, as of December 31, 2020. All others bowl scratch. Ten pin provision of U.S.B.C. Rule No. 319A-2 will apply.

ABC Rule 319 D requires bowlers to report certain information when entering handicap tournament.

ABC Rule No. 319 E will be applied to this tournament.

ABC Rule No. 319 a-3 states: Failure to use the proper average or make a correction to completion of the first game of a series shall disqualify score if submitted average is lower than actual average or base prize winnings on submitted average if it is higher.
